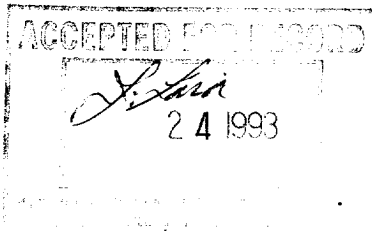

On 6/12/93, we set 4470' of 5 1/2", 15.5 ppf, J-55 production casing in a 7 7/8" open hole. The casing was cemented to surface as follows:

500 gals Mud Flush  
10 bbls fresh water spacer  
405 sks Pacesetter Lite (35:65:6) + 10% salt + 1/4 lb/sk Cello-seal  
(Slurry Weight = 12.7 ppg, Slurry Yield = 1.86 cft/sk)  
400 sks Class "C" + 0.3% CF-2 + 3% salt + 1/4 lb/sk Cello-seal

Cement was circulated to surface (134 sacks).
