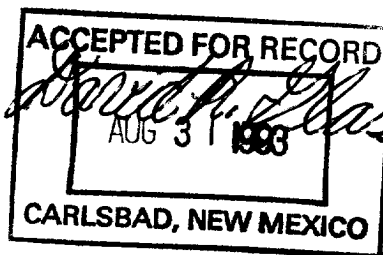

13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. On 7/12/93, we perforated the Queen sand with a 4" casing gun from 3820'-3824' and 3830'-3842' (2 spf, 32 total holes). The next day, the perfs were acidized with 1000 gals 15% NEFE acid. The well was swabbed dry and shut-in pending the frac. On 8/2/93, we fraced the perfs via 2 7/8" tubing at 22 bpm with 22,000 gals linear gelled 2% KCl water + 43,000 lbs 20/40 sand and 12,000 lbs 16/30 sand. The well was flowed back to the pit immediately following the frac for forced closure.
