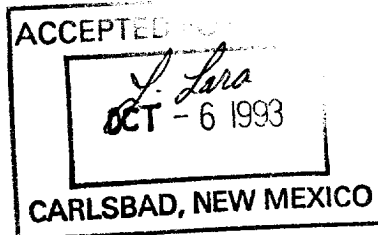

13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent data, including estimated date of starting any proposed work. On 8/27/93, we perforated additional Queen sand pay in this new well. The zone was shot with a 4" casing gun from 3762'-3766', 3397'-3415', 3424'-3430' and 3434'-3442' (1 spf). The new perms were acidized with a total of 1950 gals of 15% NEFE HCl acid + 70 ball sealers. On 8/30/93, we fraced the perms via casing with 31,854 gals gelled 2% KCl water + 50,000 lbs 20/40 sand and 15,000 lbs 16/30 sand. We shut-in the well following the frac for 4 hours. Then, we started flowing back the load. Currently, we are recovering the load and testing.
