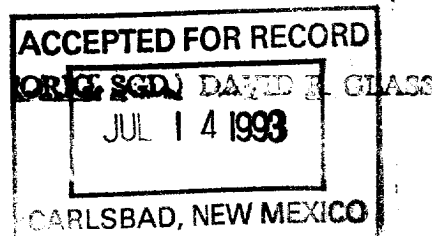

We spud this new well on 6-28-93 at 1745 hrs. On 6-29-93, we set 965' of 8 5/8", 24#, J-55 surface casing in a 12 1/4" open hole. The casing was cemented to surface with following cement slurries:

280 sx Pacesetter Lite (35:65) + 6% gel + 2% CaCl₂ + 1/4 lb/sk Cello-seal (12.7 ppg)
200 sx Class "C" + 2% CaCl₂ (14.8 ppg)

We circulated 115 sx of cement to surface.
