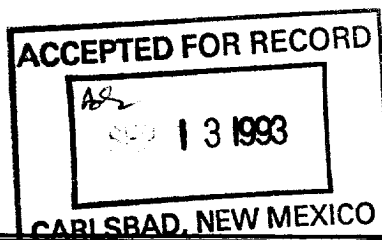

On 8/6/93, we perforated the Queen Sand with a 4" casing gun at 3765' and from 3822'-3827' and 3834'-3844' (34 holes). The perfs were acidized with 1000 gals NEFE acid + 68 ball sealers. The perfs were fraced on 8/17/93 with 29,490 gals gelled 2% KCl water + 49,500# 20/40 sand and 15,000# 16/30 sand. The well screened out with 10 bbls of flush remaining. After a 4 hour shut-in, we began flowing back the load. Currently, we are recovering the load and testing.
