#### 1. ABSTRACT

An intensive archaeological survey was conducted for DEVON ENERGY CORPORATION'S East Shugart Unit Well No. 75 [990' FNL; 330' FEL] (450' X 450'; 4.64 acres) and access road (150' X 400'; 1.37 acres) was conducted by David Wilcox, Project Director on October 18, 1995. Total area surveyed 6.01 acres. The proposed project will be situated in Section 35, T18S, R31E, NMPM, Eddy County, New Mexico. Mr. Ernie Buttross, DEVON ENERGY CORPORATION, requested the archaeological investigation. No cultural resources were encountered during the survey. Archaeological clearance for DEVON ENERGY CORPORATION'S proposed East Shugart Unit Well No. 75 and access road is recommended.

#### 2. LEGAL DESCRIPTION

T18S, R31E, Section 35, NMPM, Eddy County, NM Well Pad: (990' FNL; 330' FEL) NE1/4 NE1/4 and Access Road: SE1/4 NE1/4 NE1/4; SW1/4 NE1/4 NE1/4 NE/14

Map Reference: USGS 7.5 minute series, Greenwood Lake, NM (1985 Prov. Ed.) [Figure 1] Land Status: BLM, Roswell District, Carlsbad Resource Area, NM

#### 3. PROJECT DESCRIPTION

Well Pad (450 X 450', 4.64 acres). Access Road (150' X 400', 1.37 acres) Total area surveyed 6.01 acres. North-northwest of Greenwood Lake, east of Shugart Road and west of Eddy/Lea County line.

#### TOPOGRAPHY

Stabilized dunal field of moderate relief with associated deflation basins of shallow relief.

<u>Soils</u>: Kermit-Berino Association: Sandy, deep soils from wind-worked mixed sand deposits. <u>Water Source:</u> (Permanent) Pecos River, west 30 miles (Potential) Greenwood Lake, south-southeast 3 miles <u>Elevation:</u> 3649' <u>Aspect:</u> 360 degrees <u>Lithic Resources:</u> outside of surveyed area <u>Vegetation:</u> mesquite, yucca, shin oak, assorted grasses and snakeweed

#### 4. EXAMINATION PROCEDURE

Straight and zigzag transects, spaced not more than 15 meters apart.

Work hours on ground: 1 1/2 hours <u>Area Delineation</u>: staked by client. <u>Visibility</u>: 70-80%, due to vegetation cover <u>Lighting Conditions</u>: excellent <u>Weather</u>: sunny, breezy and warm

### 5. FINDINGS

BLM records for the area in question indicated that four previously recorded sites are within a one mile radius of the project area; however, none of these sites lie within a 2100' radius of the impact zone. David Wilcox, Project Director, conducted the records search prior to field survey.

#### 6. **RESULT OF SURVEY**

No cultural resources were encountered during the archaeological survey of DEVON ENERGY CORPORATION'S proposed East Shugart Unit Well No. 75 and access road.

#### 7. RECOMMENDATIONS

Archaeological clearance for DEVON ENERGY CORPORATION'S proposed East Shugart Unit Well No. 75 and access road is recommended.
