On 06-17-95 ran 22 jts 8 5/8" 24# J-55 8rd ST&C csg, shoe set at 939' (FC at 878', 4 centralizers). Dowell cmt'd with 300 sx Lite (with 2% CaCl2, 1/4#/sx Celloflakes) + 200 sx Class C (with 2% CaCl2). 118 sx cement circ'd to surface.

Drld 7 7/8" hole. Reached TD 4100' on 06-22-95 at 1730 hrs. Schlumberger ran GR/CNL/LDT and GR/DLL/MSFL logs.

On 06-23-95 ran 95 jts 5 1/2" 15.5# J-55 8rd LT&C csg, shoe set at 4104' (FC at 4023', 25 centralizers). Preceded cement with 500 gals mud flush CW-7. Dowell cemented with 400 sx Lite (with 5#/sx salt, 1/4#/sx Celloflakes) + 525 sx Class C (with 3% salt, .4% D59, .2% D65, 1/4#/sx Celloflakes). 85 sx cement circ'd to surface.

Released rig at 2100 hrs on 06-23-95. Waiting on completion.
