Nearburg requests permission to amend the long string casing from 7", 23#, 26#, N-80, LTC casing to 5-1/2", 17#, N80, K-55, LTC casing to a depth of 9,600'.

Drilled to 9,580'. C&C hole. Rig up and run 252 jts. 5-1/2", 17#, N80, K55, LTC csg. Set casing at 9,580'. Cement casing using 400 sx. cement plus additives. Estimated TOC @ 8,200'. WOC for 18 hrs. NU BOPE and test. Cut casing off and weld on wellhead. Release rig at 1800 hrs 12/18/97.
