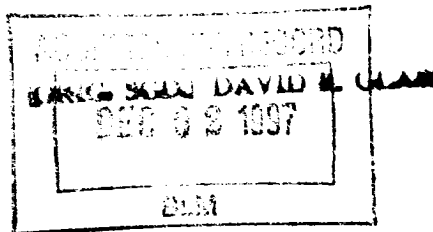

Drilled to 1,100'. C&C hole. Rig up and run 27 jts. 9-5/8", 36#, J55, LTC csg. Set casing at 1,100'. Cement casing using 860 sx. cement plus additives. Circ 70 sx cement to pit. WOC for 14 hrs. NU BOPE and test. Cut casing off and weld on wellhead.
