8/12/98: Well flowed 0 MCFG, 0 bbls condensate, and 66 BW in 24 hours. Currently venting to tank and expect to put on line shortly.

8/13/98: Well flowed on open choke: 58 MCFG, 0 bbls condensate, and 66 BW in 24 hours.

8/14/98: Well flowing on open choke: 213 MCFG, 0 bbls condensate, and 92 BW in 20 hrs. Tie well into flowline and place well back on production.

8/15/98: Well flowed 224 MCFG, 2 bbls condensate, and 73 BW in 24 hours on open choke.

It has been determined that a 4 pt. test to complete the well is not possible and Santa Fe respectfully submits the attached completion report with a daily production test as the completion test.
