12/20/98: RU csg crew & ran 15 jts 13-3/8" 48.0# H-40 ST&C, set shoe @ 700'. RU BJ & cemented csg w/ 375 sx 35:65:6 Cl "C" containing 2% CaCl2 and 1/4 pps celloflake. Tail w/ 200 sx Cl "C" + 2% CaCl2. Bump plug w/ 550 psi, float held. Circ'd 181 sx to surface. Witnessed by BLM representative Gene Hunt. WOC. Jet & clean pits. Cut csg off and weld on head. Tested weld to 500#, ok. NU BOP. PU BHA & TIH.

12/21/98: WOC. Test makeup on every DC. WOC. Test casing to 500#, ok. Drilling cement and shoe. WOC total of 24 hrs. Resume drilling formation.
