Release packer and pull out of hole.

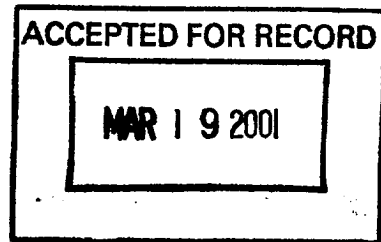
Pick up bit and bottom hole assemble to clean out sand and drill out CIBP @ 8,000'.

Kick off foam unit and clean out sand to top of cement. Drill up sand and bridge plug and clean out to second plug at approx. 8286'.

Run 2-7/8" tbg to 8255'.

Put on production w/unit running counter clockwise @ 7.5SPM
