Drill 11" hole to 2805'. Ran 63 jts - 8 5/8" - 32# - US50 scg. Cmt: Lead - 650sks Class "H" + 3% D-79 + .25 lb/sk D-29. Tail: 200sks Class "C" + 1% CaCl2. Pressure up to 1000 psi - establish rate of 900 psi. 9/26/99

Drill 7 7/8" hole to 8382'. Ran 202 jts - 5 1/2" csg. Test line to 2500 psi. Precede cmt w/25 Bbls CW-7 chemical wash followed by 25 sks 50:50 Poz Class "H" + 5% D44 + 2% D20 + .2% D59 - Wt. 12.0 ppg. - Yld 2.2 Tail: 300sks 50:50 Poz Class "H" + 5% D44 + 2% D20 = .2% D59 - Wt. 14.2 ppg - Yld 1.35 10/08/99.
