Ran 197 joints of 5-1/2" 17# & 15.5# casing as follows: 20 joints of 5-1/2" 17# S-95/P110 sandblasted (835.55'); 22 joints of 5-1/2" 17# S-95 varnished (924.87'); 10 joints of 5-1/2" 15.5# J-55 varnished (423.29'); 10 joints of 5-1/2" 15.5# J-55 sandblasted (398.68'); 127 joints of 5-1/2" 15.5# J-55 varnished (5350.03') and 8 joints of 5-1/2" 17# J-55 varnished (333.96') (Total 8269.38') of casing set at 8260'. Float shoe set at 8258'. Float collar set at 8219'. Top marker set at 5675'. Pumped 150 bbls mud with 150 scf/bbl N2 ahead of 860 sacks Poz C. (65-35-6), 3/10% FL52 and 5#/sack gilsonite (yield 1.99, weight 12.4), Tailed in with 1130 sacks Super C Modified, 5/10% FL52, 3/10% FL25, 5#/sack gilsonite and 3#/sack salt (yield 1.59, weight 13.2). PD 6:30 PM 7-15-2000. Bumped plug to 2860 psi for 1 minute, OK. Circulated 40 sacks. WOC. Released rig at 10:00 PM 7-15-2000. NOTE: Displaced casing with fresh water.
