6/04/00: LD DP & DCs. RU csg crew & ran 283 jts of 5 1/2" 17# PN&J csg, set @ 12,272'. RU BJ & circ. Cmt csg w/ 1125 sx Cl "C". PU BOPs, set slips 150K#. Cut csg.

6/05/00: Install 11"x5000 - 7-1/16x5000# tbg head & test ok. Set out BOPs, ran temp log & locate top of cmt at 6200' outside 5 1/2" csg. Jet & clean pits, rig dwn shakers & bar lines on pits. Release rig @ 4pm, 6/05/00. WO completion.
