Spudded a 26" hole with rat hole machine at 5:30 PM 9-5-2000. Drilled to 40' and set 40' of 20" conductor pipe. Cemented to surface. NOTE: Notified Gene Hunt w/BLM-Carlsbad of spud. Resumed drilling a 17-1/2" hole with rotary tools at 11:00 PM 9-12-2000. NOTE: Notified Don Early w/BLM-Carlsbad.

TD 360'. Reached TD at 10:00 PM 9-13-2000. Ran 8 joints of 13-3/8" 48# H-40 (365') of casing set at 360'. 1-Texas Pattern notched guide shoe set at 360'. Insert float set at 312'. Cemented with 200 sacks Thixad, 1% CaCl₂, 1/4#/sack celloflake and 10#/sack gilsonite (yield 1.52, weight 14.6) and 200 sacks Poz (65-35-6), 5#/sack gilsonite and 2% CaCl₂ (yield 1.97, weight 12.5). Tailed in with 200 sacks "C" and 2% CaCl₂ (yield 1.34, weight 14.8). PD 3:45 AM 9-14-2000. Bumped plug to 380 psi, OK. Circulated 185 sacks. WOC. Nippled up rotating head. Drilled out at 1:00 AM 9-15-2000. WOC 21 hours and 15 minutes. Reduced hole to 12-1/4". Resumed drilling.
