The Morrow gas has been depleted and it is our intent to recompleat to the Strawn with the following procedure:

1. Pull 2 3/8" tubing and packer.
2. Set a C.I.B.P. at 12390' and dump bail 35' of cement on top (wireline).
3. Perforate the Strawn interval 11410'-11438' with 4 jspf.
4. Acidize the new perms with 3000 gals. 15% HCl.
5. Run 2 7/8" tubing, rods and pump to 11450'.
6. Run electrical power (Central Valley Electric).
7. Install a pumping unit.
8. Put on production.
