2. Circulate hole with treated packer fluid.
3. Run tubing conveyed perforating gun and packer.
4. Set packer at ±12400'.
5. Perforate lower Morrow 12440'-54' with 4 jspf (60 holes).
6. Flow test to determine if zone is commercially productive
