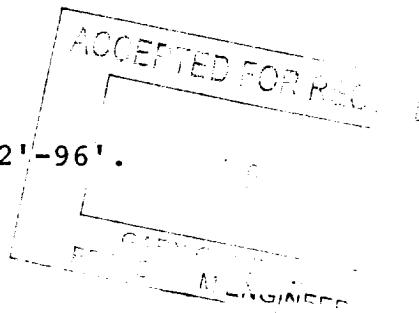

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Propose to plug back and test new interval in same zone, same pool, as follows:

1. Set a C.I.B.P. at 9825'.
2. Dump bail 35' of cement on top of C.I.B.P.
3. Perforate Bone Spring 3rd Sand 9657'-70', 9682'-96'.
4. Acidize new perfs and swab test.
5. Frac new perfs if necessary.
6. Put well back on production.
