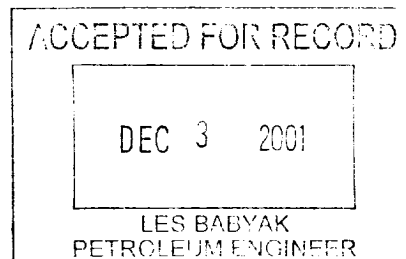

2. Perforate Bone Spring 9657'-70', and 9682'-96' w/2 jsp.
3. Acidized new perfs with 2500 gals 7.5% HCl.
4. Fraced new perfs with 66,900# 20/40 sand.
5. Prepare to test well.
