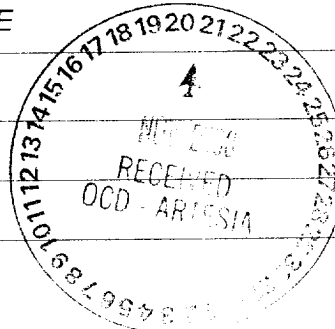

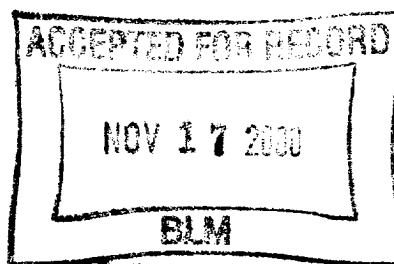

11/11/00...Drilled 12 1/4" hole to 2100'. Ran 8 5/8" 32# J csg to 2100'. Cemented 750 sks BJ Lite (12.7 #/g & 1.85 cf/sk) & tailed w/ 200 sks 'C' w/ 2% CaCl2 (14.8 #/g & 1.34 yd). Circl 135 sks to pit. WOC 12 hrs. Test BOP to 1250 psi. OK.
