1.) MIRU workover rig. Release production packer & POH w/2-7/8" tbg. & BHA. GIH w/ open-ended tbg. and plug well as follows:

- Set 165' plug in 5-1/2" csg @ 6,250' w/35 sks. Class C. POH w/tbg.
- Cut 5-1/2" csg. @ free point to recover +/- 4,800' csg. Set plug 50' inside 5-1/2" csg. / 50' inside 8-3/4" open hole @ +/- 4,850' w/50 sks. Class C. WOC & tag plug.
- Set 130' plug in 8-3/4" open hole @ 2,700' w/50 sks. Class C.
- Set 50' inside 9-5/8" / 50' inside 8-3/4" open hole w/EOT @ 1,445' w/50 sks. Class C. WOC & tag plug.
- Set 50' surface plug inside 9-5/8" csg. w/20 sks. Class C.

2.) Cut off csg. minimum 3' BGL. Install dry hole marker.
