FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

The H. H. Wilson #1 Well will be plugged immediately at a total depth of approximately 3250' by the following procedure: The hole will be pumped full of mud through tubing by Halliburton. A cement plug will be spotted in the bottom of the 10-3/4" casing. The 10-3/4" casing will be knocked off above the cement and will be pulled. The hole will be filled to the surface with mud. A cement plug will be placed at the surface and a suitable marker will be set up.
