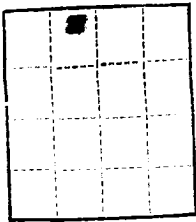

DETAILS OF WORK

The well was plugged and abandoned August 16, 1955.

940-1000 well was plugged back with gravel and 5 sacks of calceol lead, wool and oakum.

910-940 well was plugged with 8 sacks of cement, then hole was filled with mud up to the intermediate plug.

Intermediate plug 670-750 cemented with 10 sacks cement.

The surface casing was cemented and left in the hole.

7-670 well was filled with mud and 7 ft. cement plug in top.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
Placed marker, cleaned location and filled pits.
