Ran 2650' of 5 $\frac{1}{2}$ " OD 15.5# J new casing and cemented with 40 sacks in a 6 - 3/4" hole at 2658'. DF by Denton Cementing Company, Artesia, New Mexico. Allowed to set 38 hours. Texted to 1,000 psi, - no leaks. Drilled plug, float-shoe and lower cement, Then swabbed hole dry, still dry after 8 hours. Preparing to run 2 $\frac{1}{2}$ " EUE tubing to sandfrac with 1500 lbs.
