5 1/2" long-string casing has been pulled, from packer (512') upward; unmilled lower portion of Lyons (?) Packer at 512' with 3 1/2" tubing extending to TD, set in Iron/Sulfate remains in hole; along with 7" Casing, surface to 406'. No water zones exist between the Packer's 512' and 370'; a good plug through this area will effectively separate the oil zones below from water zones above.

Planned: To run tubing to packer and pump 25 sks. Class A or C Cement, let set, tag top of cement with tubing, and progressively pump 25 sks cement and tag out, back to surface: program requested by Joe Lara, Carlsbad BLM Office, 7/14/99.

Celotex or other loss circulation material, mixed in drilling mud, may be placed prior any cement plug; also loss circulation material may be added to cement if needed to obtain solid plugging.

The Tank Battery at the Riggs 3 will remain onsite to be used by the Taylor 8 well, possibly the Riggs 6, and also for a contemplated Riggs 3Y replacement well for this plugged Riggs 3, to be drilled after the Taylor 8 is completed.

Mr. Joe Lara, 7/14/99, requested his review of these plans and plugging input from himself be noted for the Roswell Office's information.

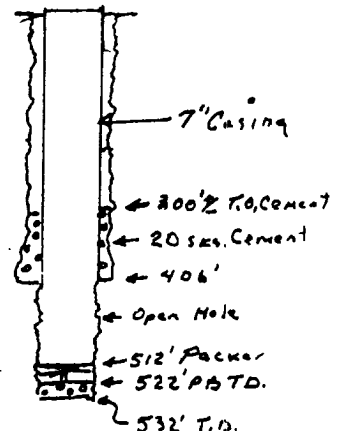
