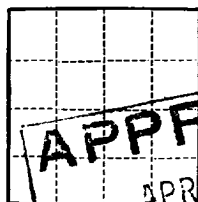

Packer stuck in Input well #10 - unable to remove, so will drill 10 X exactly 100' south of #10. With rotary, will set approximately 3 joints of 8 5/8" csng. Then drill 6 3/4" rotary hole to a point 5' or so above Russell Sand expected at 775'. Russell Sand will be cored and hole reamed if necessary to cement to surface if possible the 4" casing on top or in the Russell Sand. After completion of 10 X - Well #10 will be plugged.

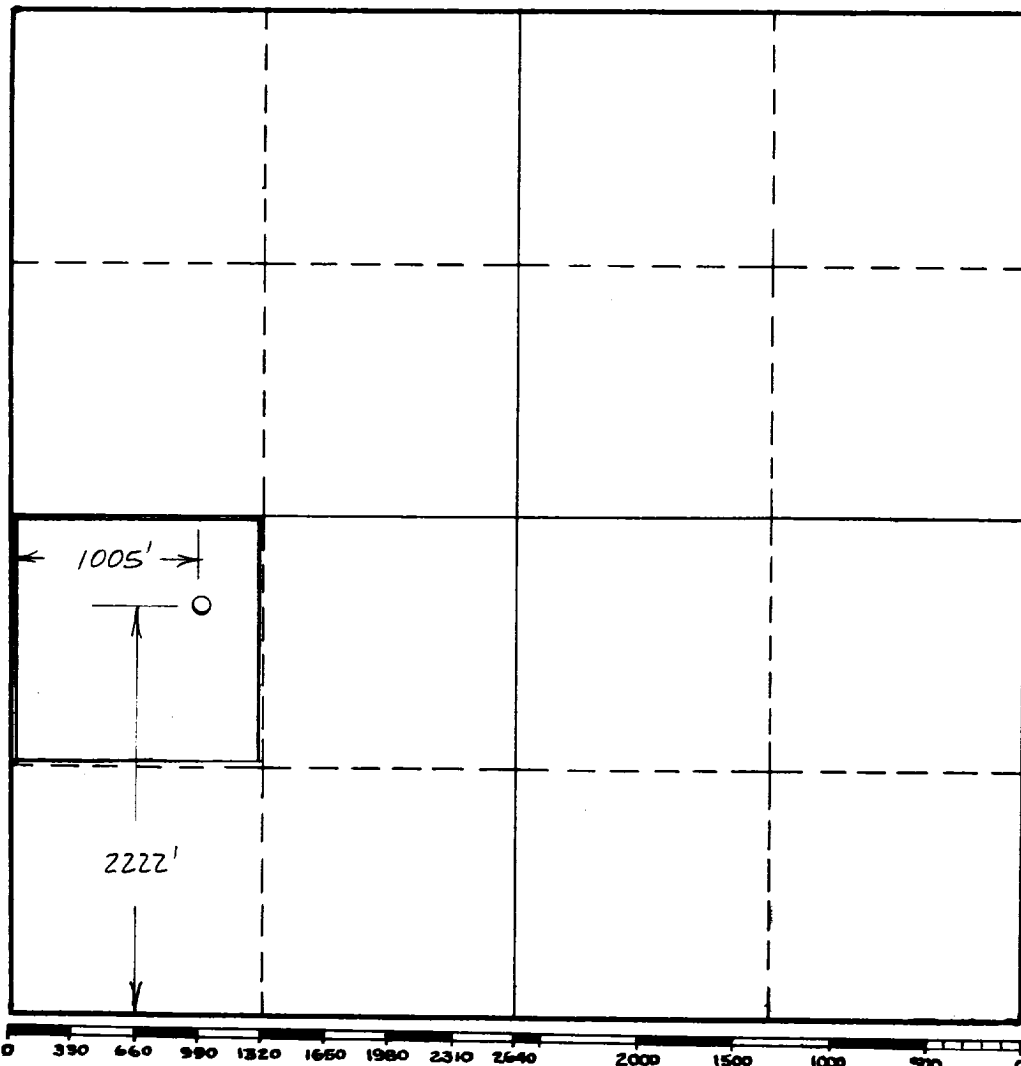
