7"-new 22 1/2 sm's 8 rd thrd csg was cemented at 1143 with 50 sac cement on 8-9-42. Cement set 72 hrs. when hole was bailed and plug drilled. Cement job was successful and drilling was resumed today at 1159 with oil pay encountered at 1157-59. Hole will be taken to a depth of about 1520 feet.
