9/23/93 - Set up on hole and started drilling with 12 1/2" bit. Lost circulation at 190'. Continued drilling to 231' and hit old 8-5/8" casing. Come out of hole.

9/24/93 - Welded 7' of 10-3/4" casing to 8-5/8" casing and ran into hole. Placed 10-3/4" pipe over top of old 8-5/8" casing.

9/27/93 - Pumped water in well and leveled out at 50'-60'. Ran into hole with 6 1/2" bit and got inside old 8-5/8" casing about 10'. Haliburton set 35 sack cement between old and new casing.

9/28/93 - Plug holding water. Drilled out cement from 210'. Got into old casing and drilled down to plug at 314'. Drilled plug rest of day. Brass steel and cement returns.

9/29/93 - Broke thru plug and continued down hole easily. Hit old 7" casing at 891' as reported.

9/30/93 - Ran tubing and collars into hole and got into 7" casing about 5' and came out of hole. Haliburton placed 200 sack to 640'.

10/1/93 - Pumped another 200 sack and let set. Mixed 230 sack and filled to surface.

10/4/93 - Set marker and cleaned location
