457'3" of 8 5/8" casing was cemented at a depth of 460' by Halliburton with 50 sax cement at 9 AM on April 12, 1941. Gyp water was encountered at a depth of 68-83' and 102' of 12 1/2" casing was run to shut off surface cave. Top of salt was encountered at 455'. After running 8 5/8" casing, 12 1/2" casing was pulled. Cement on 8 5/8" casing will set 72 hrs until Tuesday morning (4/15/41) when hole will be bailed and plug drilled. If hole is dry drilling will be resumed.
