Total depth 1696', 5½" casing at 1641' with 300 sacks (circulated).

Well has been temporarily abandoned since March 21, 1968.

It is proposed to plug well by pumping neat cement down casing and filling hole with cement. Estimated cement is 215 sacks. Cement will be mixed with potash water. A suitable 4" pipe marker will be placed at the surface.

It is estimated work will be commenced within a few days.
