13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports shall be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 shall be filed once testing has been completed. Prepare location, rig up workover rig, lay down rods and 4 1/2" tubing, nipple up BOP, run bit on 2 3/8" workstring to 1692', run CIBP and set at approximately 1685', pressure test casing. If casing pressure does not hold, we will plug and abandon the well as follows: TIH to CIBP and pump 100' cement plug, displace hole with saltwater gel, pump 100' cement plug from 1645' to 1245' (base of salt), pump 100' cement plug from 615' to 515' (top of salt) pump 100' cement plug from 515' to 415' (surface casing shoe), pump 50' cement plug at surface and weld on dry hole marker, cover pit, rip and reseed location, take down power poles and wire.
