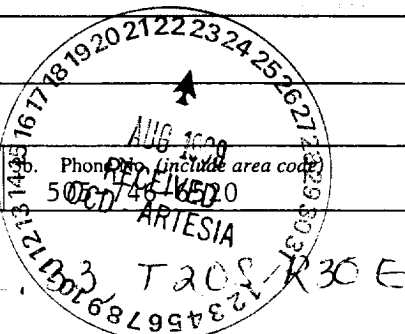

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Operator proposes to plug and abandon the above well as follows:

- 1.) Pull tubing. Set CIBP @ 1550' @ cap with 50' cement
- 2.) Cir hole with mud containing 25# bbl gel
- 3.) Set cement across salt from 1350'-475' TAG
- 4.) Set cement plug from 60' to surface
- 5.) Cut off well head and install dry hole marker
- 6.) Cut off anchors and clean up location
