We propose to drill Shell-Texas Crude Big Eddy Unit 1-30 as a 7500-foot Bone Spring test as follows:

We propose to drill Shell-Texas Crude Oil test as follows:
Drill 17 1/4" hole in the Red Beds, or in the the top of the Anhydrite to approximately 700' & cement 13 3/8" casing (Circulate cement to surface).
Drill 17 1/4" hole in the Red Beds, or in the the top of the Anhydrite to approximately 2010' & cement 9 5/8"

Drill 12 1/4" hole into the ~~Tasili~~ dolomite at approximately 2010' & cement 9 5/8" casing (Circulate cement to surface).

Drill 7 7/8" or 8 3/4" hole into the Bone Springs at approximately 7500' and cement 5 1/2" casing.

This test will be drilled in accordance with NMOCC Order R-111-A.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

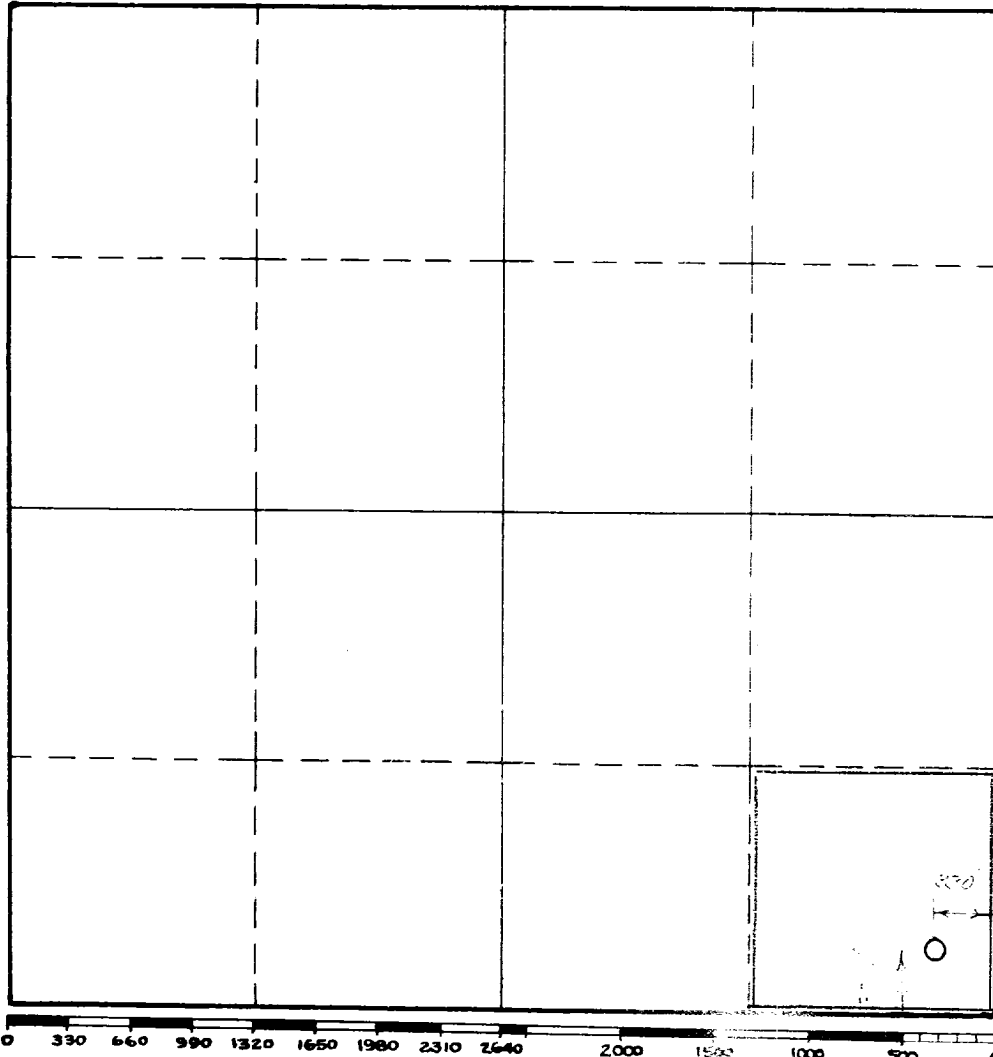

Gentlemen:

Shell Oil Company and Texas Crude Oil Company plan to drill a 7500 foot well located 310' from the north line and 330' from the South line of Section 30, T-20-S, R-31-E, Eddy County, New Mexico, to explore for oil and gas in the Bone Spring and Bone Spring formations. Enclosed is a copy of U.S. Geological Survey Form C-128, which set out our proposed drilling program. These reports are being filed with the B.L.M. office.

The above well will be drilled on Federal Lands under an Oil and Gas Lease issued by the United States to Walter Salazar under date of June 1, 1952, and bearing Serial Number 100618. Shell Oil Company and Texas Crude Oil Company are drilling this lease under a Designation of Agent Agreement from the present owner. This lease is committed to the Big Eddy Unit which has been approved, and the well will be drilled under the unit plan.

According to our information, you have filed an application for a potash lease under the drill site, Section 31, and also the S-1/2 and NW-1/4 of Section 19, and the NE-1/4 of Section 31, All in T-20-S, R-31-E. Also in accordance with our information, you own potash leases under the NE-1/4 of Section 19, All of Sections 21, 29, and 32, and the S-1/2 of Section 31, All in T-20-S, R-31-E, and the E-1/2 and SW-1/4 of Section 24 and All of Sections 25 and 36, All in T-20-S, R-30-E, Eddy County, New Mexico. We are writing you this letter inasmuch as your potash holdings are within a one mile radius of our location.
