6-9-93: Dug out cellar, cleaned location and removed dry hole marker. Welded on 9-5/8" stub with 11" X 3000 starting head. Set anchors. Nippled up BOP. Tested blind rams to 500 psi, OK. TIH w/8-3/4" bit, drill collars and tubing to 3155'. Tested pipe rams to 500 psi, OK. NOTE: Notified Shannon Shaw w/BLM with the BLM in Carlsbad about spud.

Washed down to 4650'. Tagged cement plug at 4650'. Drilled cement from 4650-4880'. Washed down to 5972'. Tagged cement plug at 5972'. Drilled cement from 5972-6072'. Washed down to 8300'. Drilled cement plug from 8300-8415'. Washed down to 9366'. Drilled cement plug from 9366-9466'. Washed down to 9902'. Circulated clean.

TOOH w/tubing, drill collars and bit. Ran logs. TIH w/bit, drill collars and tubing to 3155'. Rigged up on 6 line. TIH to 9902'. Circulated 2-1/2 hours. TOOH w/tubing, drill collars and bit. Changed 2-7/8" tubing rams. Installed 7" casing rams.
