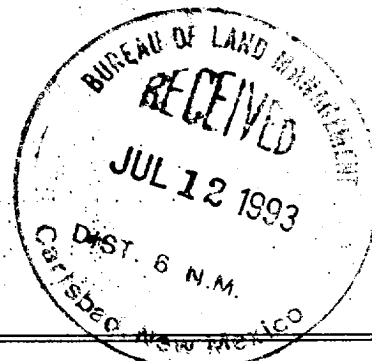

Set standing valve in 1.81" profile nipple. Got off of on/off tool and TOOH with tubing and on/off tool. TIH w/RBP and tubing. Set RBP at 9403'. Tested RBP to 1000 psi for 10 minutes, OK. TOOH w/tubing. TIH w/casing gun and perforated 7608-7623' w/10 .42" holes as follows: 7608, 09, 14, 19 & 7623'. TOOH. TIH w/RBP, packer and tubing to 7683'. Set RBP at 7683'. Tested RBP to 1000 psi, OK. Set packer at 7558'. Acidized perforations 7608-7623' w/1500 gallons 15% NEFE acid and ball sealers. Evaluating.

Unset packer at 7558'. Moved down and unset RBP at 7683'. TOOH w/tubing, packer and RBP. Turned over to production department.
