7-10-2001 - Cleaned location and set anchors. Moved in and rigged up pulling unit. Nippled up BOP. TIH with bit and drill collars and tubing to 4500'. Shut well in for night.
7-11-2001 - Finished TIH with bit, drill collars and tubing and tagged up at 8565'. Pickled tubing with 800 gallons 15% NEFE acid. Displaced hole with 7% treated fluid. TOOH with bit, drill collars and tubing. Shut well in.
7-12-2001 - Rigged up wireline. TIH with logging tools and ran CBL/GR/CCL log. TOOH with logging tools. TIH with 4" casing guns and perforated 7952-8022' w/45 .42" holes as follows: 7952-7972' (21 holes), 7994-7996' (3 holes) and 8002-8022' (21 holes) (1 SPF - Canyon). TOOH with casing guns and rigged down wireline. TIH with packer and RBP with ball catcher. Set RBP at 8062' and tested to 1000 psi. Set packer at 7652' and tested to 1000 psi. Nippled up wellhead and valve. Shut well in.
7-13-2001 - Acidized perforations 7952-8022' with 50000 gallons gelled 20% HCL acid. Swabbed. Shut well in.
7-14-2001 - Swabbed. Shut well in.
7-15-16-2001 - Swabbed. Shut well in.
