Intermediate String: 9-5/8" casing set @ 5000'. Cmt to surface.
Oil String: 5-1/2" casing set @ 13,200'. Cmt w/350 sks cement.

Projected TD: 13,200'

Prospective Pay: Devonian

DST all zones with shows below Yates formation. Selectively perforate and treat all prospective producing intervals after setting oil string.
