Marathon Oil Company proposed to isolate water production and add perforations in the
above referenced well beginning 8-13-90 or upon approval of Form 3160-5. Following is
the procedure:

1. Test safety anchors.
2. Install H₂S safety equipment.
3. MIRU pulling unit.
4. Kill well w/2% KCl.
5. ND wellhead and NU BOP's.
6. POOH w/tbg and packer.
7. RU full lubricator.
8. RIH w/3 3/8" casing guns & perforate Upper Penn from 7362'-68' and 7373'-78'
w/4 JSPF.
9. RIH w/packer and set at ±7484'.
10. RIH w/seal assembly, 3 jts tbg, Lok-set packer and sliding sleeve in open
position on 2 7/8" tbg. Sting seal assembly into "Retrieva-D" packer and
set Lok-set packer at ±7394'.
11. ND BOP's. NU wellhead.
12. RU swab.
13. Swab well to frac tank to establish production.
14. Turn well to production unit.
15. RD pulling unit.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
