4. RU wireline contractors. Dump bailed 35' cmt onto CIBP @ 9300'.
5. RIH w/7" CIBP on wireline & set @ 7400'. Dump bailed 35' cmt onto CIBP.
6. RD wireline contractors.
7. RIH w/2 7/8" workstring open ended. Circulated hole w/920 bbls 10# plugging mud. Tested plug to 1000#. Held O.K. POOH w/2 7/8" workstring.
8. RU wireline contractors. Perforated @ 6193' w/4 holes.
9. RD wireline contractors.
10. RIH w/model "R" double grip pkr on 2 7/8" workstring & set @ 6010'.
11. RU cementers
12. Established pump in rate @ 2 BPM @ 2500#.
13. RD cementers.
14. Released pkr & POOH.
15. RU wireline contractors.
