DETAILS OF WORK

Cement 5 joints 7" OD, 20# casing, @ 155 ft w/15 sacks to shut off surface waters. Drill 6" rotary hole to top of Russell sand. Run 4 1/2" casing @ 10 cemented w/60 sacks (calculated enough to fill 150% through salt section). Will drill 4" rotary hole through sand. Will then decide on producing or injecting into the sand.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

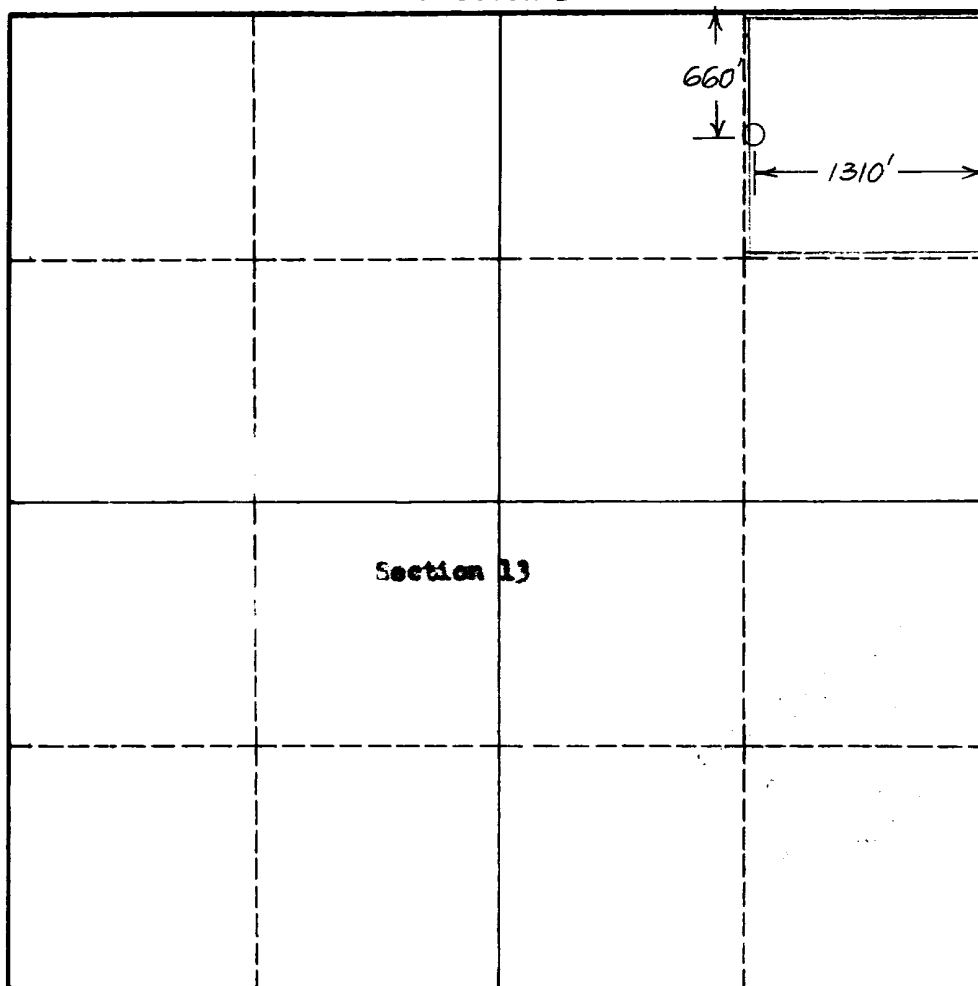

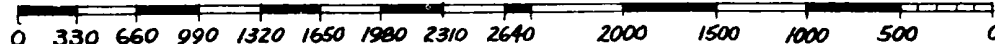
