30 sack cement plugs were set at 4000 to 3900 feet, 2550 to 2450 feet, 975 to 825 feet and 10 sack cement plug at surface. Hole was loaded between plugs with mud. A 4' stake with required information on same was cemented in place at surface. Location was cleaned and pits were covered. Location is ready for your inspection and approval.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
