Air drilled 12-1/4" hole to 3135'. Sulfur water flows at 1600' and 1843'. Estimated at 15 BPH. Ran 97 jts 9-5/8" OD 8R Combination casing w/float collar and float shoe=3117.69'. Set at 3130.17'. Cemented w/733 sx Incor + 4% gel + 2% Ca Cl, followed by 150 sx Incor neat. Plug down at 6:30 A.M. 4/11/64. Cement circulated. Ran 8-3/4" bit, drilled cement inside casing to 3094'. Tested 9-5/8" casing to 1000' for 30 min. Held OK & job complete at 10:30 P.M. 4/12/64. After 39 hrs WOC started air drilling formation at 2:00 A.M. 4/13/64. Well dusted beneath casing shoe.
