Perforated 8 holes 9512'-9514' (1/2 inch) by Lane Wells. Pressured to 6000 psig (bottom) and could not circulate mud.

Swabbing, swabbed 15 bbls liquid and then mud level came up within 1000 ft. of surface.

Swabbing from a level of 6500 feet, which appears to fairly static. Mud is 10.2 lb. and is very viscons. About 50 bbls have been recovered.

Cemented with 275 sxs of Incor Neat. Top of cement by Temperature Survey 6850'.
