Set at 355.34' RKB. Cemented w/370 sx Incor neat + 2% Ca Cl. Cement circulated. Plug down at 5:30 P.M. 5/13/64. WOC 21-1/2 hours. Tested 13-3/8" casing to 850# for 30 minutes. OK and job complete at 3:30 P.M. 5/14/64. Air drilled below casing shoe and well dusted.
