Marathon Oil Co. tested the mechanical integrity of this well 1/26/96. The casing tubing annulus was pressured up to 510 PSIG. The Pressure was held and recorded for the required time (30 minutes) with 5 PSI leak off. The test was witnessed by BLM representative Mr. J.D. Whitlock. Marathon requests that this well be granted Temporary Abandonment status. This well has potential as a Co Production candidate. (lifting large quantities of water with associated gas). The potential for such production should be evaluated before December 1997. A copy of the original pressure recording chart is attached.
