

Marathon Oil Co. is requesting renewal of the TA status of this well. The casing integrity was tested on 8/17/99 and TA status was originally approved 8/24/94. A copy of the 8/17/99 integrity test chart, witnessed by J. D. Whitlock, is included. Marathon plans to drillout the CIBP, which is set @ 7810', perforate additional pay in the Upper Penn interval, stimulate the well and run a sub pump. This work was scheduled for the 2nd quarter of 1999, however the workover schedule has been changed. It is not known at this time when this work will be completed.


