DETAILS OF WORK

Drilled 1 7/8" hole to 320'. Ran 10 jts. 13-3/8" casing @ 320' and cemented with 670 sacks of Incor neat plus 2% CaCl. Cement circulated. W.O.C. 18 hrs. and tested water free. Drilled out from 13-3/8" casing with 1 1/2" bit to 1785' and ran 57 jts. 9-5/8" casing and cemented with 965 sacks of Incor. Cement circulated. W.O.C. 18 hrs. and tested casing to 1000 pounds water free.
