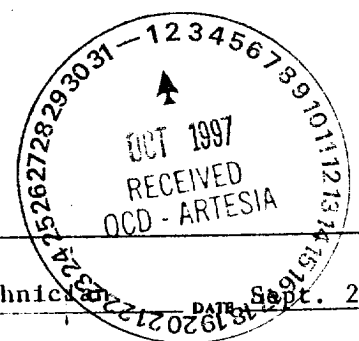

9-23-97 - Moved in and rigged up pulling unit. Nippled down wellhead and installed BOP. TOOH with tubing and subpump. TIH with retrieving tool and 2-7/8" tubing. Latched onto RBP at 8411'.
9-24-97 - Unset RBP at 8411'. TOOH. TIH with 2-7/8" tubing. Latched onto packer at 9469'. Removed BOP and nipped up wellhead. Rigged up slickline. TIH and pulled blanking plug out of packer at 9469'. Rigged down slickline. Flared well down. Shut well in.
9-25-97 - Released well to production department.
