10/25-27/02 Pumped 50 bbls 2% KCL down tubing and casing. Nipped down wellhead. Nipped up BOP. TIH with bit and scraper.

10/28/02 Tagged up at 8280'. TIH with cement retainer set at 8105'. TIH with stinger. Stung in cement retainer.

10/29/02 Squeeze off Canyon perms with 200 sx Thixotropic and 200 sx "H" Neat. Staged cement for 2-1/2 hours. Stung out of retainer.

10/30/02 Pumped 200 sx Thixotropic with 1% Calcium + 200 sx "H" Neat with 1% Calcium. Did not squeeze. Pumped 200 sx "H" Neat with 2% Calcium and 200 sx "H" Neat. Stung out of retainer. Circulated out 18 bbls cement.

11/1-3-02 Squeezed Canyon perms with 200 sx Thixotropic with 1% Calcium + 200 sx "H" Neat.

11/5/02 Re-squeeze Canyon with 100 sx Thixotropic + 100 sx "H" Neat. Drilled out RBP w/ ball catcher at 8300'.

Well is now producing from it's original Morrow completion.
